## What is Permanent Residency (PR) in **Canada**?

Permanent Residency allows a person to live, work, and study anywhere in Canada indefinitely.

PR holders are not Canadian citizens, but they have many of the same rights (except voting and holding certain government jobs).

After a few years as a PR, you may apply for Canadian citizenship.

# How to Get Permanent Residency in **Canada**?

## Express Entry (Skilled Workers)

- Based on age, education, work experience, language (English/French)
- Programs: Federal Skilled Worker, Canadian Experience Class, Federal Skilled Trades

## Provincial Nominee Program (PNP)

- Apply through a specific province or territory that nominates you

## Family Sponsorship

- If you have a close family member (spouse, parent, child) who is a Canadian citizen or PR, they can sponsor you

## Study or Work in Canada → PR Pathway

- Many international students or workers apply for PR after gaining Canadian experience

## ▶ General Steps in the Process

**Check eligibility:** Meet requirements (language, education, experience)

**Submit profile or application** (e.g., Express Entry profile)

- ▶ Receive invitation to apply (ITA)
- ▶ Submit full PR application with documents
- ▶ Medical check & background check
- ▶ Get PR approval & COPR (Confirmation of Permanent Residence)
- ▶ Land in Canada as a PR

## ▶ Visitor Visa (Temporary Resident Visa)

A Visitor Visa allows foreign nationals to enter Canada temporarily for tourism, family visits, or business. It's usually valid for up to 6 months

- ▶ You must show you will leave Canada before your visa expires.
- ▶ You need enough funds for your stay.
- ▶ You should have clear purpose for visiting Canada
- ▶ You should add documents like a letter of invitation from someone in Canada or travel plans.
- ▶ A visa does not guarantee entry; the border officer has the final say. (New rule)
